Transmitter-Front



- 1 DC 48V: Plug in AC Power Adaptor

- 5 IR OUT1-Connect the IR Blaster, ensure direct line-of-sight

- 1 Power LED Status Indicator

- 5 RS232 3 Pin OUT: Connect to device to be controlled

Transmitter—Side Panels




- 1 LAN-Connect to Ethernet device or to a local network. Left LED illuminates yellow to indicate LAN connection & flashes indicating data transmission. Right LED illuminates green when Ethernet speed is 110Mbit/s.
- 2 OPT. OUT: Connect to an audio receiver or powered speaker set.
- 3 ARC OUT ON/OFF:
 - ON: ARC audio routed to the HDMI input & OPT.OUT port. To ensure the best audio quality use cables under 6.5 feet (2 meters) OFF: No ARC will pass
- 4 HDMI IN: Connect to HDMI source.
- 5 CAT5e/6/7 OUT: Connect to the RX. Left LED illuminates yellow when TX & RX are connected & flashes when there is a data link ERROR. Right LED illuminates green when PoH is active.

Receiver—Side Panels



- 1 LAN-Connect to Ethernet device or to a local network. Left LED illuminates yellow to indicate LAN connection & flashes indicating data transmission. Right LED illuminates green when Ethernet speed is 110Mbit/s.
- 2 OPT. IN: Connect to an audio source.
- 3 ARC IN/OPT.IN: Switch between sending audio to TX from HDMI output ARC channel or from the RX OPT.IN port. To ensure the best audio quality use cables under 6.5 feet (2 meters)
- 4 HDMI OUT: Connect to HDMI display or amplifier
- 5 CAT5e/6/7 OUT: Connect to the TX. Left LED illuminates yellow when TX & RX are connected & flashes when there is a data link ERROR. Right LED illuminates green when PoH is active.
